Immunizations Expense category shows a negative balance of \$15737.00 When I looked at the transactions, they were actually for two deposits. It appears that the Immunization expense account was selected in error instead of the Immunizations and Medications income account??

### **Expenditures: Issue Identified**

The year end total for depreciation expense should be \$58564. Currently it shows \$58718.72 leaving a difference of \$154. I recommend that we reduce the Dec depreciation by \$154 to bring it into balance for the year. The Dec depreciation would then be \$4751, instead of \$4905.

Cure MD – payment of 749 – this has been reported previously in C19 Adult Immunization. When I checked that expense account, I do not see that payment reported for 749 since 10/26/23. It may be correct as it is, but I thought that I would mention it to you.
